PRIVACY POLICY

In the interest of the security of entrusted personal data, the Administrator operates based on internal procedures and recommendations, in accordance with the legal provisions on the protection of personal data, in particular the Regulation of the European Parliament and of the Council (EU) 2016/679 of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and the repeal of Directive 95/46 EC (RODO).

4. The Administrator takes special care to protect the interests of the data subjects and, in particular, ensures that personal data is:

a. processed in accordance with the law;

b. collected for specified, legitimate purposes and not subject to further processing incompatible with these purposes;

c. Substantially correct and adequate in relation to the purposes for which they are processed;

d. stored in a form that permits identification of persons to whom they relate, no longer than is necessary to achieve the purpose of processing.

5. Personal data are processed on the basis of the consent expressed by the users of the Website and in cases where the provisions of applicable law authorize the Administrator to process personal data.

6. The Administrator processes personal data provided by Website users only to respond to a contact.

7. Providing personal data is voluntary, however, failure to provide data to the extent required by the administrator may result in a lack of response to the initiated contact.

8. Personal data of website users are not sold or made available to third parties (subject to point 11) and are not subject to profiling, automated processing in order to assess and determine personal characteristics or users' needs.

- e. legal regulations that may oblige the Administrator to process data for a specified period of time;

13. The administrator performs the functions of obtaining information about users and their behavior in the following way:

- a. by voluntarily entering information,
- b. by collecting "cookies".

14. The first time you visit www.perfandled.pl, you are informed about the use of cookies. By staying on the site, the user accepts the use of ordinary cookies on the website. No change on the part of users of browser settings is tantamount to consenting to the use of "cookies".
